(SPRF) an adoption fee of: The Adopter understands that the adoption fee is immediately spent on saving another pet's life and, therefore, if the cat is returned for any reason, the adoption fee is non-refundable after 30 days. The Adopter agrees to have the cat examined by a licensed veterinarian at least once each year and will receive adequate vaccinations and treatments to ensure good health. The Adopter will provide the cat with a safe home, proper care, attention, which includes a healthy diet, fresh water, and shelter. The Adopter agrees to never declaw the cat under any circumstances and understands that declawing can cause serious physical, psychological, and behavioral complications. The adopter understands that scratching is a normal behavior and will provide scratching posts, pads and keep cat's nails trimmed. In the event Saving Paws Rescue of Florida discovers inhumane treatment of the adopted animal or breach of this contract, it is agreed that SPRF has the right to immediately take possession of the cat. It is understood by the Adopter that a representative of the Saving Paws Rescue of Florida, Inc. may conduct a home visit to verify the welfare of the adopted animal if there is suspected abuse or neglect. The Adopter agrees to keep the Saving Paws Rescue of Florida, Inc. informed of any address or phone number changes. The Adopter agrees to notify the Saving Paws Rescue of Florida, Inc. of any incident involving Animal Control and/or complaints arising from ownership of adopted cat and/or If the adopted animal becomes lost or stolen. Saving Paws Rescue of Florida, Inc. makes no warranties or guarantees regarding the animal's health, medical status, or temperament.
